Formed in 2020, the Panel encourages dialogue and engagement between business and civic leaders to share ideas and solutions as we progress on Canada's clean energy journey.

OUR MISSION

To advance practical policy solutions that strengthen Canada's energy security and economic resilience by championing nuclear and other made-in-Canada energy solutions—positioning Canada as a clean energy superpower.



PRACTICAL AND ACTIONABLE

With a refreshed mission, expanded membership and renewed guiding principles, the Green Ribbon Panel has prepared four timely, relevant and practical policy recommendations focused on strengthening Canada's energy security and economic resilience—championing nuclear and other made-in-Canada energy solutions.



1. FINISHING THE JOB OF INVESTMENT TAX CREDITS (ITCs)

Extend Clean Economy Investment Tax Credits beyond the mid-2030s to unlock investment in long-lead clean energy projects that strengthen Canada's energy future and standardizing the credit to 30 per cent.



2. ADOPTING ENERGY AS AN INDUSTRIAL POLICY

Create an industrial policy to grow Ontario's manufacturing base and supply chain by consolidating energy sector buying power and addressing tariffs.



3. STRENGTHENING INDIGENOUS ENGAGEMENT CAPACITY AND ECONOMIC OPPORTUNITIES

Ensure Indigenous communities have the resources to engage early and share long-term economic benefits through sustainable funding and harmonized loan guarantees.



4. ADVANCING "NO-REGRET" INVESTMENT ACTIONS

Enable early investment in clean energy projects through innovative financing and staged approvals to reduce risk and speed up development.

We are launching the Panel's 100-day plan today.

It starts with a letter to the Prime Minister of Canada calling for action and continues with a dynamic podcast series aimed at policymakers, plus broad engagement across our members.
